## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0419

Affirmed TRA Benefits Denied - Week 6-16

**PROCEDURAL HISTORY:** On February 23, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant TRA benefits for week 6-16 (February 7, 2016 to February 13, 2016) (decision # 110118). Claimant filed a timely request for hearing. On April 1, 2016, ALJ Holmes-Swanson conducted a hearing, and on April 7, 2016 issued Hearing Decision 16-UI-56730, affirming the Department's decision. On April 12, 2016, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 16-UI-56730 is affirmed.

Decision # 105125 denied claimant TRA benefits for week 9-16 (February 28, 2016 to March 5, 2016). A second decision, the number of which is unknown to EAB, denied claimant TRA benefits for week 11-16 (March 1, 2016 to March 19, 2016). Decision # 195711 assessed a \$548 overpayment, \$82.20 monetary penalty and 4 penalty weeks based on decision # 110118. Claimant has requested hearings on decision # 105125 and # 195711; as of the date this decision was issued, the Office of Administrative Hearings had not yet scheduled those hearings. It is unclear to EAB whether or not claimant has requested a hearing on the week 11-16 TRA denial.
