## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0490

Affirmed
Late Request for Hearing Denied
Overpayment Assessed

**PROCEDURAL HISTORY:** On January 26, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 73927) concluding that claimant did not actively search for work from December 13, 2015 through January 2, 2016 (weeks 50-15 through 52-15). On February 16, 2016, decision # 73927 became final without an application for review having been filed. On February 29, 2016, the Department issued a decision (decision # 154608) assessing a \$594 overpayment based on decision # 73927. On March 11, 2016, claimant filed an untimely request for hearing on decision # 73927 and a timely request for hearing on decision # 154608. On April 18, 2016, ALJ Shoemake conducted hearings, and on April 26, 2016, issued the following hearing decisions: Hearing Decision 16-UI-58133 affirmed decision # 73927 and Hearing Decision 16-UI-58138 affirmed decision # 154608. On April 30, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-58133 and 16-UI-58138. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0490 and 2016-EAB-0495).

EAB reviewed the entire hearing records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-58138 and 16-UI-58133 are affirmed.
