**EMPLOYMENT APPEALS BOARD DECISION**  
**2016-EAB-0528**

*Affirmed*  
*Late Requests for Hearing Dismissed*  
*Ineligible*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On July 14, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from November 22, 2014 through March 7, 2015 (decision # 115334). On August 3, 2015, decision # 115334 became final without a request for hearing having been filed. On August 14, 2015, the Department served notice of an administrative decision concluding that claimant was overpaid \$3,192 in benefits and must repay that amount to the Department (decision # 94915). On September 3, 2015, decision # 94915 became final without a request for hearing having been filed. On March 18, 2016, claimant filed late requests for hearing on decisions # 115334 and 94915. On March 28, 2016, ALJ Kangas issued Hearing Decisions 16-UI-55908 and 16-UI-55910, dismissing claimant's late requests for hearings subject to claimant's right to renew her requests by responding to an appellant questionnaire by April 11, 2016. On April 6, 2016, the Office of Administrative Hearings (OAH) received claimant's response, and on April 19, 2016, ALJ Kangas issued Hearing Decisions 16-UI-57611 and 16-UI-57631, re-dismissing claimant's late requests for hearing on decisions # 115334 and 94915. On May 2, 2016, claimant filed applications for review of Hearing Decisions 16-UI-57611 and 16-UI-57631 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-57611 and 16-UI-57631. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0527 and 2016-EAB-0528).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-57611 and 16-UI-57631 are affirmed.
