PROCEDURAL HISTORY: On March 11, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 115106). On March 14, 2016, the Department issued an administrative decision (decision # 200342) assessing a \$5,682 overpayment, a \$1,704.60 monetary penalty, and 46 penalty weeks. On March 31, 2016, decision # 115106 became final without a request for hearing having been filed. On April 1, 2016, claimant filed a timely hearing request on decision # 200342 and an untimely hearing request on decision # 115106. On May 12, 2016, ALJ Wyatt conducted hearings, and on May 16, 2016, issued the following hearing decisions: Hearing Decision 16-UI-59604 dismissed claimant's late request for hearing on decision # 115106, and Hearing Decision 16-UI-59606 affirmed decision # 200342. On June 6, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-59604 and 16-UI-59606. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0683 and 2016-EAB-0684).

EAB reviewed the entire hearing records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-59604 and 16-UI-59606 are affirmed.
