PROCEDURAL HISTORY: On April 25, 2016, the Oregon Employment Department (the Department) served notice of the following two administrative decisions: decision # 110633 concluded that claimant voluntarily left work without good cause and decision # 112750 concluded that claimant was not available for work from March 20 through April 9, 2016 (weeks 12-16 through 14-16). Claimant filed timely requests for hearing. On June 7, 2016, ALJ M. Davis conducted hearings, and on June 10, 2016, issued the following two hearing decisions: Hearing Decision 16-UI-61482 concluded that claimant voluntarily left work with good cause, and Hearing Decision 16-UI-61483 concluded that claimant was available for work from March 20 through April 9, 2016, April 17 through 23, 2016 and May 1 through May 28, 2016. On June 15, 2016, the employer filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-61482 and 16-UI-61483. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0707 and 2016-EAB-0708).

EAB reviewed the entire hearing records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-61482 and 16-UI-61483 are affirmed.
