PROCEDURAL HISTORY: On April 8, 2016, the Oregon Employment Department (the Department) served two notices of two administrative decisions concluding claimant did not actively seek work from November 28, 2015 to January 30, 2016 (decision # 64629) and January 31, 2016 to February 20, 2016 (decision # 101602). Claimant filed timely requests for hearing on both decisions. On May 20, 2016, ALJ Monroe conducted a consolidated hearing, and on May 27, 2016 issued Hearing Decision 16-UI-60682, concluding claimant did not actively seek work from November 29, 2015 to January 30, 2016, and Hearing Decision 16-UI-60680, concluding claimant *did* actively seek work from February 7, 2016 to February 13, 2016, but did not actively seek work from January 31, 2016 to February 6, 2016 and February 14, 2016 to February 20, 2016. On June 16, 2016, claimant filed applications for review of both hearing decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-60680 and 16-UI-60682. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0716 and 2016-EAB-0717).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-60680 and 16-UI-60682 are affirmed.
