## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0794

Affirmed
Late Request for Hearing Dismissed
Late Request to Reopen Denied

**PROCEDURAL HISTORY:** On October 29, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 73650). On November 17, 2015, claimant filed a timely request for hearing on decision # 73650. On January 14, 2016, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for January 28, 2016, at which claimant failed to appear. On January 28, 2016, ALJ Wipperman issued Hearing Decision 16-UI-51853, dismissing claimant's request for hearing for failure to appear.

On February 4, 2016, the Department served notice of another administrative decision assessing a \$997 overpayment (decision # 92442). On February 17, 2016, Hearing Decision 16-UI-51853 became final without claimant having filed a timely request to reopen or application for review with the Employment Appeals Board (EAB). On February 24, 2016, decision # 92442 became final without claimant having filed a timely request for hearing. On May 24, 2016, claimant filed a late request to reopen the January 28th hearing and a late request for hearing on decision # 92442.

On June 1, 2016, OAH mailed notice of a hearing on both matters scheduled for June 16, 2016. On June 16, 2016, ALJ M. Davis conducted two hearings, and on June 17, 2016, issued Hearing Decision 16-UI-61992, dismissing claimant's late request for hearing on decision # 92442, and Hearing Decision 16-UI-62008, denying claimant's late request to reopen the January 28, 2016 hearing on decision # 73650. On July 6, 2016, claimant filed applications for review of both hearing decisions with EAB.

EAB considered claimant's written argument when reaching this decision.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-61992 and 16-UI-62008. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0794 and 2016-EAB-0796).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-61992 and 16-UI-62008 are affirmed.
