## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0821

Affirmed
Requests to Reopen Denied

PROCEDURAL HISTORY: On April 18, 2016, the Oregon Employment Department (the Department) served notice of the following administrative decisions: decision # 91403 concluded that claimant voluntarily left work, and decision # 92106 concluded that claimant was not available for work from March 27 through April 9, 2016 (weeks 13-16 and 14-16). Claimant filed timely hearing requests. On May 4, 2016, the Office of Administrative Hearings issued notice of two hearings scheduled for May 19, 2016, at which claimant failed to appear. On May 19, 2016, ALJ M. Davis issued Hearing Decision 16-UI-59995, dismissing claimant's hearing request on decision # 91403, and Hearing Decisions 16-UI-59975, dismissing claimant's hearing request on decision # 92107. On June 8, 2016, Hearing Decisions 16-UI-59995 and 16-UI-59975 became final without applications for review or requests to reopen having been filed. On June 16, 2016, claimant filed untimely requests to reopen. On June 16, 2016, ALJ Kangas issued Hearing Decisions 16-UI-62871 and 16-UI-62779, dismissing claimant's late requests to reopen as untimely. On July 8, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-62781 and 16-UI-62779. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0821 and 2016-EAB-0822).

EAB reviewed the entire records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-62781 and 16-UI-62779 are affirmed.
