## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0840

Affirmed (Confirmada) Late Request for Hearing Dismissed (Petición Tardía Para Una Audencia Negada)

**PROCEDURAL HISTORY:** On May 10, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 133125) concluding that claimant did not actively search for work from March 6 through April 2, 2016 (weeks 11-16 through 13-16). On May 31, 2016, decision # 133125 became final without a request for hearing having been filed. On June 2, 2016, claimant filed an untimely request for hearing. On June 8, 2016, ALJ Kangas issued Hearing Decision 16-UI-61286, dismissing claimants hearing request as untimely, subject to claimant's right to renew the request by submitting a response to an appellant questionnaire within 14 days of the date on which the decision was mailed. On June 23, 2016, claimant submitted an untimely response to the appellant questionnaire and also filed an application for review with the Employment Appeals Board (EAB). By letter to claimant dated June 27, 2016, the Office of Administrative Hearings (OAH) explained that claimant's response to the appellant questionnaire was untimely and would not be considered, and that Hearing Decision 16-UI-61286 remained in effect.

EAB considered the entire hearing record and claimant's written argument to the extent it was relevant and based on evidence in the record. *See* ORS 657.275(2) and OAR 471-041-0090 (October 29, 2006). On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

**DECISION:** Hearing Decision 16-UI-61286 is affirmed. *Decisión de la Audiencia 16-UI-61286 queda confirmada.*
