EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0970

Hearing Decisions 16-UI-65875 and 16-UI-65897 Affirmed Late Request for Hearing Dismissed Overpayment Assessed

PROCEDURAL HISTORY: On May 27, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from November 29, 2015 through May 21, 2016 (decision # 80333). On June 16, 2016, decision # 80333 became final without claimant having filed a request for hearing. On June 29, 2016, the Department served notice of a decision, based on decision # 80333, concluding that claimant was overpaid \$4,134 in benefits that she must repay (decision # 110244). On July 12, 2016, claimant filed a late request for hearing on decision # 80333 and a timely request for hearing on decision # 110244. On August 15, 2016, ALJ Triana conducted hearings, and on August 18, 2016 issued Hearing Decision 16-UI-65875, dismissing claimant's late request for hearing on decision # 80333, and Hearing Decision 16-UI-65897, affirming decision # 110244. On August 24, 2016, claimant filed applications for review of Hearing Decisions 16-UI-65875 and 16-UI-65897 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-65875 and 16-UI-65897. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0970 and 2016-EAB-0969).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-65875 and 16-UI-65897 are affirmed.
