EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-0972

Affirmed Request to Reopen Denied

PROCEDURAL HISTORY: On March 30, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (# 95138) concluding that claimant did not actively search for work from January 24 through February 6, 2016 (weeks 4-16 and 5-16) and March 6 through March 26, 2016 (weeks 10-16 through 12-16). On April 29, 2016, decision # 95138 became final without a request for hearing having been filed. On June 7, 2016, claimant filed an untimely hearing request. On June 13, 2016, ALJ Kangas issued Hearing Decision 16-UI-61616, dismissing claimant's hearing request as untimely, subject to claimant's right to renew the request by responding to an appellant questionnaire within 14 days. Claimant timely responded to the appellant questionnaire. By letter dated June 24, 2016, the Office of Administrative Hearings (OAH) cancelled Hearing Decision 16-UI-61616. Also on June 24, 206, OAH issued notice of a hearing scheduled for July 13, 2016. On July 14, 2016, ALJ Wyatt issued Hearing Decision 16-UI-63713, dismissing claimant's hearing request for failure to appear at the July 13 hearing. On August 3, 2016, claimant filed a request to reopen. On August 8, 2016, ALJ Kangas issued Hearing Decision 16-UI-65175, denying claimant's request to reopen. On August 23, 2016, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's argument to the extent it was relevant and based on the hearing record.

EAB considered the entire record in this case. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 16-UI-65175 is affirmed.
