Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 23, 2016, the Oregon Employment Department (the Department) served notice of administrative decision #133613 that concluded that claimant voluntarily left work without good cause, and decision #135715 that concluded that claimant was not available for work from May 8 through June 18, 2016 (weeks 19-16 through 24-18). On July 13, 2016, both decisions became final without a request for hearing having been filed. On August 8, 2016, claimant filed requests for hearing on both decisions. On August 10, 2016, ALJ Kangas issued Hearing Decision 16-UI-65354, dismissing claimant's request for hearing on decision #135715 as untimely, and Hearing Decision 16-UI-65356, dismissing claimant's request for hearing on decision #133613 as untimely. Both hearing decisions were subject to claimant's right to renew his hearing requests by responding to appellant questionnaires within 14 days. Claimant did not respond to the appellant questionnaires. On August 29, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-65354 and 16-UI-65356. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-0993 and 2016-EAB-0994).

EAB reviewed the entire records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decision 16-UI-65354 is affirmed.
