**EMPLOYMENT APPEALS BOARD DECISION**  
**2016-EAB-1031**

*Affirmed*  
*Confirmada*

*Late Requests for Hearing Dismissed ~ Ineligible ~ Disqualification ~ Overpayment, No Penalties*  
*Peticiones Tardías para Audiencia Negadas ~ No Elegible ~ Descalificación ~ Sobrepena, No Sanciones*

**PROCEDURAL HISTORY:** On March 28, 2016, the Oregon Employment Department (the Department) served two notices of two administrative decisions, one concluding claimant did not actively seek work from January 31, 2016 to March 5, 2016 (decision # 84757), and the second concluding that claimant voluntarily left a job without good cause (decision # 83932). On March 30, 2016, the Department issued notice of an amended decision # 84757. On April 18, 2016, decision # 83932 became final without claimant having filed a timely request for hearing. On April 19, 2016, amended decision # 84757 became final without claimant having filed a timely request for hearing. On April 28, 2016, the Department served notice of an administrative decision assessing a \$1086 overpayment claimant was liable to have deducted from future benefits payable (decision # 131837). On May 18, 2016, decision # 131837 became final without claimant having filed a timely request for hearing. On June 1, 2016, the Department served notice of an administrative decision concluding that claimant did not actively seek work from April 24, 2016 to May 14, 2016 (decision # 84616). On June 21, 2016, decision # 84616 became final without claimant having filed a timely request for hearing. On July 15, 2016, the Department served two notices of two administrative decisions, one concluding claimant did not actively seek work from August 16, 2015 to October 10, 2015 and October 25, 2015 to November 14, 2015 (decision # 81751), and the second concluding that claimant did not actively seek work from March 27, 2016 to April 2, 2016 (decision # 82731). On July 19, 2016, the Department served notice of an administrative decision assessing a \$7,021 overpayment, \$2,106.30 monetary penalty and 52 penalty weeks.

On July 25, 2016, claimant filed timely requests for hearing on decisions # 193752, 82731 and 81751, and late requests for hearing on decisions # 84757, 131837, 84616 and 83932. On August 17, 2016, ALJ R. Frank conducted a consolidated hearing. On August 24, 2016, the ALJ issued Hearing Decisions 16-UI-66220, 16-UI-66222, 16-UI-66231 and 16-UI-66221, dismissing claimant's late requests for hearing on decisions # 84757, 131837, 84616 and 83932, respectively. The ALJ also issued

Hearing Decision 16-UI-66255, concluding claimant was overpaid and required to repay \$7,021 but not liable for penalties, Hearing Decision 16-UI-66237, affirming decision # 82731, and Hearing Decision 16-UI-66232, affirming decision # 81751.

On September 1, 2016, claimant filed timely applications for review of all seven hearing decisions with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-66220, 16-UI-66221, 16-UI-66222, 16-UI-66231, 16-UI-66232, 16-UI-66237 and 16-UI-66255. For case-tracking purposes, this decision is being issued in septuplicate (EAB Decisions 2016-EAB-1025, 2016-EAB-1026, 2016-EAB-1027, 2016-EAB-1028, 2016-EAB-1029, 2016-EAB-1030 and 2016-EAB-1031).

EAB reviewed the entire record of each case under review. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-66220, 16-UI-66221, 16-UI-66222, 16-UI-66231, 16-UI-66232, 16-UI-66237 and 16-UI-66255 are affirmed. *Decisión de la Audiencia 16-UI-66220, 16-UI-66221, 16-UI-66222, 16-UI-66231, 16-UI-66232, 16-UI-66237 y 16-UI-66255 quedan confirmadas.*
