**EMPLOYMENT APPEALS BOARD DECISION**  
**2016-EAB-1064**

*Affirmed*  
*Requests to Reopen Denied*

**PROCEDURAL HISTORY:** On May 25, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from April 24 through May 21, 2016 (decision # 95713). On June 27, 2016, the Department served notice of a decision concluding that claimant therefore was overpaid \$597 in benefits that he must repay to the Department (decision # 131503). Claimant filed requests for hearing on both decisions. The Office of Administrative Hearings (OAH) scheduled hearings for July 29, 2016. On July 29, 2016, ALJ M. Davis issued Hearing Decisions 16-UI-64759 and 16-UI-64761, dismissing claimant's requests for hearing due to claimant's failure to appear at the hearings. On August 17, 2016, claimant filed requests to reopen the hearings. On August 24, 2016, ALJ Kangas issued Hearing Decisions 16-UI-66240 and 16-UI-66242, dismissing claimant's requests. On September 8, 2016, claimant filed applications for review of Hearing Decisions 16-UI-66240 and 16-UI-66242 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-66240 and 16-UI-66242. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-1061 and 2016-EAB-1064).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decision 16-UI-66240 and 16-UI-66242 are affirmed.
