## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-1066

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

**PROCEDURAL HISTORY:** On June 23, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 94913). On July 13, 2016, decision # 94913 became final without claimant having filed a timely request for hearing. On July 26, 2016, the Department served notice of a decision concluding that claimant therefore was overpaid \$940 in benefits that he must repay to the Department (decision # 112947). On August 8, 2016, claimant filed a late request for hearing on decision # 94913 and a timely request for hearing on decision # 112947. On August 31, 2016, ALJ Murdock conducted hearings, and on September 2, 2016 issued Hearing Decision 16-UI-66894 dismissing claimant's late request for hearing on decision # 94913, and Hearing Decision 16-UI-66876 affirming decision # 112947. On September 9, 2016, claimant filed applications for review of Hearing Decisions 16-UI-66894 and 16-UI-66876 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-66894 and 16-UI-66876. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-1066 and 2016-EAB-1067).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-66894 and 16-UI-66876 are affirmed.
