## EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-1160

## Affirmed Ineligible Weeks 23-16 and 24-16

**PROCEDURAL HISTORY:** On July 8, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 100608) concluding that claimant did not actively seek work from June 5 through June 18, 2016 (weeks 23-16 and 24-16). On July 28, 2016, decision # 53291 became final without a request for hearing having been filed. On August 11, 2016, the Department served notice of an administrative decision (# 125853) assessing a \$311 overpayment based on decision # 53291. On August 24, 2016, claimant filed an untimely request for hearing on decision # 100608 and a timely request for hearing on decision # 125853. On September 29, 2016, ALJ Shoemake conducted hearings, and on October 4, 2016, issued Hearing Decision 16-UI-68502, which dismissed claimant's request for hearing on decision # 100608, and Hearing Decision 16-UI-68504, which affirmed decision # 125853. On October 4, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-68502 and 16-UI-68504). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-1159 and 2016-EAB-11160).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-68502 and 16-UI-68504 are affirmed.
