PROCEDURAL HISTORY: On July 22, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from June 19, 2016 to July 16, 2016 (decision # 133535). On August 11, 2016, decision # 133535 became final without claimant having filed a request for hearing. On August 25, 2016, the Department served notice of a decision assessing a \$1,520 overpayment he was liable to repay (decision # 140030). On September 1, 2016, claimant filed a late request for hearing on decision # 133535 and a timely request for hearing on decision # 140030. On October 13, 2016, ALJ Shoemake conducted hearings on both of claimant's requests and issued Hearing Decision 16-UI-69187, dismissing claimant's late request for hearing on decision # 133535, and Hearing Decision 16-UI-69188, affirming the assessment of an overpayment. On October 24, 2016, claimant filed applications for review of both hearing decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-69187 and 16-UI-69188. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-1209 and 2016-EAB-1210).

EAB reviewed both hearing records in their entirety. On de novo review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-69187 and 16-UI-69188 are affirmed.
