PROCEDURAL HISTORY: On September 16, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 142459). On October 6, 2016, decision # 142459 became final without claimant having filed a request for hearing. On October 18, 2016, the Department served notice of an administrative decision (# 95439) assessing a \$1,436 overpayment, based on decision # 142459. On November 3, 2016, Claimant filed a late request for hearing on decision # 142459, and a timely request for hearing on decision # 95439.

On November 15, 2016, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 142459 scheduled for December 1, 2016 at 1:30 p.m., and notice of a hearing on decision # 95439 scheduled for December 1, 2016 at 2:30 p.m. On December 1, 2016, claimant failed to appear at the hearing on decision # 142459, and appeared at the hearing on decision # 95439. ALJ Shoemake conducted a hearing on decision # 95439. On December 2, 2016, ALJ Shoemake issued Hearing Decision 16-UI-72132, dismissing claimant's request for hearing on decision # 142459 due to his failure to appear at the hearing on that decision. Also on December 2, 2016, ALJ Shoemake issued Hearing Decision 16-UI-72138, affirming decision # 95439.

On December 7, 2016, claimant filed a request to reopen the hearing on decision # 142459. On December 8, 2016, claimant filed an application for review of Hearing Decision 16-UI-72138 with the Employment Appeals Board (EAB). On December 13, 2016, ALJ Kangas issued Hearing Decision 16-UI-72822, denying claimant's request to reopen the hearing on decision # 142459. On January 3, 2017, Hearing Decision 16-UI-72822 became final without EAB having received a timely application for review of that decision.

EAB reviewed the entire hearing record on decision # 95439. On *de novo* review and pursuant to ORS 657.275(2), Hearing Decision 16-UI-72138 is **adopted**.

DECISION: Hearing Decision 16-UI-72138 is affirmed. *Decisión de la Audiencia 16-UI-72138 queda confirmada.*
