EMPLOYMENT APPEALS BOARD DECISION 2016-EAB-1421

Affirmed Ineligible Weeks 23-16 and 24-16 Overpayment Assessed

PROCEDURAL HISTORY: On September 7, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 93300) concluding that claimant did not actively search for work from June 5 through June 18, 2016 (weeks 23-16 and 24-16). On September 27, 2016, decision # 93300 became final without a request for hearing having been filed. On October 11, 2016, the Department served notice of an administrative decision (# 145704), assessing an \$834 overpayment based on decision # 93300. On October 18, 2016, claimant filed an untimely request for hearing on decision # 93300, and a timely request for hearing on decision # 145704. On December 1, 2016, ALJ Vincent conducted hearings, and on December 1, 2016, issued Hearing Decision 16-UI-72010, which allowed claimant's late hearing request on decision # 93300 and affirmed the decision, and Hearing Decision 16-UI-72009, which affirmed decision # 145704. On December 20, 2016, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-72010 and 16-UI-72009. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2016-EAB-1422 and 2016-EAB-1421).

EAB reviewed the hearing records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 16-UI-72009 and 16-UI-72010 are affirmed.
