<p><b>EMPLOYMENT APPEALS BOARD DECISION</b> <b>2017-EAB-0057</b></p>

*Affirmed*  
*Late Request for Hearing Allowed*  
*Not Eligible*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On October 17, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from June 5, 2016 to July 2, 2016 (decision # 84458). On November 7, 2016, decision # 84458 became final without claimant having filed a timely request for hearing. On November 23, 2016, the Department served notice of an administrative decision, based on decision # 84458, assessing a \$966 overpayment that claimant was required to repay (decision # 142918). On November 29, 2016, claimant filed a late request for hearing on decision # 84458 and a timely request for hearing on decision # 142918. On December 27, 2016, ALJ Triana conducted two hearings, and on December 28, 2016 issued Hearing Decision 16-UI-73733, allowing claimant's late request for hearing and affirming decision # 84458, and Hearing Decision 16-UI-73735, affirming decision # 142918. On January 23, 2017, claimant filed applications for review of both hearing decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 16-UI-73733 and 16-UI-73735. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0057 and 2017-EAB-0058).

EAB reviewed the entire hearing records. On de novo review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 16-UI-73733 and 16-UI-73735 are affirmed.
