PROCEDURAL HISTORY: On November 16, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 103523) concluding that claimant did not actively seek work from October 16 through November 12, 2016 (weeks 42-16 through 45-16). On December 6, 2016, decision # 103523 became final with no request for hearing having been filed. On December 27, 2016, the Department served notice of an administrative decision (decision # 112851) which assessed a \$2,093 overpayment based on decision # 103523. On January 3, 2017, claimant filed a late request for hearing on decision # 103523 and a timely request for hearing on decision # 112851. On January 30, 2017, ALJ Shoemake conducted hearings, and on January 31, 2017, issued Hearing Decision 17-UI-75777, which dismissed claimant's late request for hearing on decision # 103523, and Hearing Decision 17-UI-75799, which affirmed decision # 112851. On February 7, 2017, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-75777 and 17-UI-75799. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0145 and 2017-EAB-0146).

EAB considered claimant's written argument to the extent it was relevant and based on evidence in the record.

EAB considered the entire hearing records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 17-UI-75777 and 17-UI-75799 are affirmed.
