

EMPLOYMENT APPEALS BOARD DECISION
2017-EAB-0148

Affirmed ~ Confirmada
Request to Reopen Denied ~ Petición de Reabrir Negada

PROCEDURAL HISTORY: On December 1, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from November 13, 2016 to November 19, 2016 (decision # 103240). Claimant filed a timely request for hearing. On December 28, 2016, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for January 11, 2017, at which claimant did not appear. On January 11, 2017, ALJ Seideman issued Hearing Decision 17-UI-74473, dismissing claimant's request for hearing for failure to appear. On January 23, 2017, claimant filed a request to reopen the January 11, 2017 hearing. On January 24, 2017, ALJ Kangas reviewed claimant's request and issued Hearing Decision 17-UI-75331, denying claimant's request to reopen. On February 6, 2017, claimant filed an application for review of Hearing Decision 17-UI-75331 with the Employment Appeals Board (EAB).

EAB considered claimant's written argument when reaching this decision. The notice of hearing, which claimant stated her daughter read to her from English, stated "At the time of hearing, you must call . . ." and stated in Spanish, "A la hora fijada para la audiencia, usted debe llamar . . ." Given those unambiguous instructions, provided in both English and Spanish, we must conclude that it was within claimant's reasonable control to read and follow the instructions to call, and her decision to wait for someone to call her, although a mistake, was not excusable. Therefore, and for the reasons explained in Hearing Decision 17-UI-75331, claimant's mistaken belief that the ALJ would call her to participate in the January 11, 2017 hearing did not amount to good cause to reopen the hearing.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 17-UI-75331 is affirmed.
