## EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-0158

Affirmed
Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On September 9, 2016, the Oregon Employment Department (the Department) served notice of administrative decision # 120617, which concluded that claimant did not actively search for work from July 3 through July 9, 2016, and administrative decision # 122104, which concluded that claimant did not actively search for work from July 24 through August 13, 2016. On October 11, 2016, both administrative decisions became final without requests for hearing having been filed. On January 6, 2017, claimant filed late requests for hearing on both decisions. On January 12, 2017, ALJ Kangas issued Hearing Decision 17-UI-74561, which dismissed claimant's request for hearing on decision # 120617 as untimely, and Hearing Decision 17-UI-74559, which dismissed claimant's request for hearing on decision # 122104 as untimely. Both decisions were subject to claimant's right to renew his hearing requests by responding to an appellant questionnaire within 14 days. Claimant timely responded to the appellant questionnaires. On January 26, 2017, ALJ Kangas issued Hearing Decision 17-UI-75514, which re-dismissed claimant's request for hearing on decision # 120617, and Hearing Decision 17-UI-75513, which re-dismissed claimant's request for hearing on decision # 122104. On February 6, 2017, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-75513 and 17-UI-75514. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0157 and 2017-EAB-0158).

EAB reviewed the entire records in these cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-75513 and 17-UI-75514 are affirmed.
