EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-0203

Affirmed Overpayment Assessed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 9, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause on July 1, 2016 (decision # 115901). On September 29, 2016, decision # 115901 became final, without a request for hearing having been filed. On October 11, 2016, the Department served notice of an administrative decision (decision # 134023) concluding that claimant was overpaid \$399 in unemployment benefits, based on decision # 115901. On October 14, 2016, claimant filed a timely hearing request on decision # 134023 and an untimely hearing request on decision # 115901. On February 10, 2017, ALJ Meerdink conducted a consolidated hearing, and issued Hearing Decision 17-UI-76729, dismissing as untimely claimant's request for hearing on decision # 115901. On February 13, 2017, ALJ Meerdink issued Hearing Decision 17-UI-76776, affirming administrative decision # 134023. On February 21, 2017, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-76729 and 17-UI-76776. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0203 and 2017-EAB-0204).

FINDINGS OF FACT: (1) On June 21, 2016, claimant filed an initial claim for unemployment benefits. Her claim was determined to be valid, and a weekly benefit amount of \$133 was established.

(2) Claimant claimed and was paid \$133 per week in benefits for weeks 26-16, 27-16, and 29-16. Claimant received a total of \$399 for those weeks. When claimant filed her claim for benefits for week 26-16 (June 26 through July 2, 2016), she stated that she had not quit a job during that week.

CONCLUSION AND REASONS: EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), <u>Hearing Decision 17-UI-76729</u> is **adopted.**

For the reasons set forth below, we agree with the ALJ and conclude that claimant was overpaid benefits that she was not entitled to receive. <u>Hearing Decision 17-UI-76776</u> is therefore **affirmed.**

ORS 657.310(1) provides that an individual who received benefits to which the individual was not entitled is liable to either repay the benefits or have the amount of the benefits deducted from any future benefits otherwise payable to the individual under ORS chapter 657. That provision applies if the benefits were received because the individual made or caused to be made a false statement or misrepresentation of a material fact, or failed to disclose a material fact, regardless of the individual's knowledge or intent. *Id*.

Claimant is ineligible to receive benefits for weeks 26-16, 27-16, and 29-16 as a matter of law based on decision # 115901, which, as of the date this decision is being issued, is final. The Department paid claimant \$399 in benefits for those weeks, making claimant overpaid. The Department paid claimant based on her report that she had not quit a job during week 26-16, an assertion that is, regardless of claimant's knowledge or intent when making it, false as a matter of law. Because the Department's payment of benefits to claimant for weeks 26-16, 27-16 and 29-16 was based on her false statement, claimant is liable to either repay the amount she was overpaid or have it deducted from future benefits otherwise payable.

DECISION: Hearing Decisions 17-UI-76729 and 17-UI-76776 are affirmed.
