<p><b>EMPLOYMENT APPEALS BOARD DECISION</b> <b>2017-EAB-0288</b></p>
--

*Affirmed*  
*Ineligible Weeks 9-16 through 39-16*  
*Overpayment and Penalties*

**PROCEDURAL HISTORY:** On November 9, 2016, the Oregon Employment Department (the Department) served notice of four administrative decisions concluding that claimant voluntarily left work with Lawrence Service Company on March 7, 2016 without good cause (decision # 92223), was not available for work from February 28 through October 1, 2016 (decision # 104113), was not available for work from August 21 through September 3, 2016 (decision # 112044), and was not available for work from September 11 through 17, 2016 (decision # 112546). On November 10, 2016, the Department served notice of an administrative decision (decision # 193562) concluding that claimant willfully made misrepresentations and failed to report material facts to obtain benefits, was overpaid \$6,623 in benefits she must repay, is disqualified for 47 weeks of future benefits, and must pay a \$1,986.90 monetary penalty. Claimant filed timely requests for hearing on all five decisions. On February 23, 2017, ALJ Murdock conducted hearings, and on March 2, 2017 issued Hearing Decision 17-UI-78024 reversing decision # 92223, and Hearing Decisions 17-UI-78022, 17-UI-78020, 17-UI-78021 and 17-UI-78165 affirming decisions # 104113, 112044, 112546 and 193562. On March 7, 2017, claimant filed timely applications for review of Hearing Decisions 17-UI-78022, 17-UI-78020, 17-UI-78021 and 17-UI-78165 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions Hearing Decisions 17-UI-78022, 17-UI-78020, 17-UI-78021 and 17-UI-78165. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2017-EAB-0286, 2017-EAB-0287, 2017-EAB-0285 and 2017-EAB-0288).

EAB reviewed the hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-78022, 17-UI-78020, 17-UI-78021 and 17-UI-78165 are affirmed.
