**EMPLOYMENT APPEALS BOARD DECISION**  
**2017-EAB-0300**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Ineligible Weeks 36-16 through 38-16*  
*Overpayment*

**PROCEDURAL HISTORY:** On October 11, 2016, the Oregon Employment Department (the Department) served notice of administrative decision # 104700, concluding that claimant did not actively seek work from September 4 through 24, 2016 (weeks 36-16 through 38-16). On October 31, 2016, decision # 104700 became final without claimant having filed a request for hearing. On November 14, 2016, the Department served notice of administrative decision # 162436, concluding, based on decision # 104700, that claimant was overpaid \$1,462 in benefits for weeks 36-16 through 38-16 that he must repay. On November 17, 2016, claimant filed a late request for hearing on decision # 104700 and a timely request for hearing on decision # 162436. On February 9, 2017, ALJ Frank conducted hearings, and on February 17, 2017 issued Hearing Decisions 17-UI-77222 and 17-UI-77232, dismissing claimant's request for hearing on decision # 104700 as untimely without good cause, and affirming decision # 162436. On March 9, 2017, claimant filed applications for review of Hearing Decisions 17-UI-77222 and 17-UI-77232 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-77222 and 17-UI-77232. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0300 and 2017-EAB-0301).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-77222 and 17-UI-77232 are affirmed.
