## EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-0443

Affirmed
Requests to Reopen Denied

**PROCEDURAL HISTORY:** On December 5, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision (decision # 133734) concluding that claimant filed a late claim for benefits for week 45-16 (November 6 through 12, 2016). On December 14, 2016, the Department served notice of an administrative decision concluding that claimant voluntarily left work without good cause (decision # 125939). Claimant filed timely requests for hearing. On February 17, 2017, the Office of Administrative hearings issued notices of hearings scheduled for March 3, 2017. On March 3, 2017, ALJ Seideman issued Hearing Decision 17-UI-78128, dismissing claimant's request for hearing on decision # 133734 for failure to appear, and Hearing Decision 17-UI-78127, dismissing claimant's request for hearing on decision # 125939 for failure to appear. On March 23, 2017, both decisions became final without requests for reopening or applications for review having been filed. On April 3, 2017, claimant filed untimely requests to reopen. On April 12, 2017, ALJ Kangas issued hearing decision 17-UI-80871, dismissing claimant's request to reopen the hearing on decision # 133734, and Hearing Decision 17-UI-80857, dismissing claimant's request to reopen the hearing on decision # 125939. On April 17, 2017, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-80871 and 17-UI-80857. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-0442 and 2017-EAB-0433).

EAB reviewed the entire records in both cases. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-80871 and 17-UI-80857 are affirmed.
