EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-1403

Affirmed Late Request for Hearing Dismissed Overpayment Assessed

PROCEDURAL HISTORY: On August 2, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from December 11, 2016 through January 7, 2017 (decision # 70228). On August 22, 2017, decision # 70228 became final without claimant having filed a request for hearing. On September 12, 2017, the Department served notice of an administrative decision, based on decision # 70228, concluding that claimant was overpaid \$580 in benefits for the weeks from December 25, 2016 through January 7, 2017 that he must repay the Department (decision # 131857). On September 26, 2017, claimant filed a late request for hearing on decision # 70228 and a timely request for hearing on decision # 131857. On October 23, 2017, ALJ Shoemake conducted hearings, and on October 24, 2017 issued Hearing Decision 17-UI-95209 dismissing claimant's late request for hearing on decision # 70228 as untimely without good cause, and Hearing Decision 17-UI-95229 affirming decision # 131857. On November 10, 2017, claimant filed timely applications for review of Hearing Decisions 17-UI-95209 and 17-UI-95209 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-95209 and 17-UI-95229. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-1403 and 2017-EAB-1316).

In written argument, claimant asserted that he actively sought work from December 11, 2016 through January 7, 2017. Claimant further asserted that he should not be required to repay the \$580 in benefits he received for the weeks from December 25, 2016 through January 7, 2017 because, to the best of his knowledge, he was claiming/filing correctly and eligible for those benefits, was at no fault, and did his best to understand and follow the rules/instructions when filing. However, we reviewed the hearing records in their entirety and agree with the ALJ's dismissal of claimant's request for hearing on decision # 70228 as untimely without good cause. Claimant therefore did not actively seek work from December 11, 2016 through January 7, 2017, and is not eligible for benefits for those weeks, as a matter of law. We therefore agree with the ALJ that claimant must repay the \$580 in benefits he received for the weeks

from December 25, 2016 through January 7, 2017 regardless of his knowledge or intent when claiming benefits for those weeks.

On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 17-UI-95209 and 17-UI-95229 are affirmed.
