EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-1419

Affirmed Ineligible Overpayment, No Penalties

PROCEDURAL HISTORY: On August 9, 2017, the Oregon Employment Department (the Department) served notice of administrative decision # 141812 concluding that claimant did not actively seek work from November 15 through December 26, 2017; and administrative decision # 193621 concluding that claimant willfully failed to report that he did not actively seek work to obtain benefits, was overpaid \$3114 in benefits, is disqualified for future benefits, and assessed a monetary penalty. Claimant filed timely requests for hearing on both decisions. On November 20, 2017, ALJ Shoemake conducted hearings, and on November 21, 2017 issued Hearing Decision 17-UI-97391 affirming decision # 141812, and Hearing Decision 17-UI-97414 modifying decision # 193621 by concluding that claimant was overpaid \$3114 in benefits, but is not disqualified for future benefits or assessed a monetary penalty. On December 11, 2017, claimant filed applications for review of Hearing Decisions 17-UI-97391 and 17-UI-97414 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-97391 and 17-UI-97414. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-1417 and 2017-EAB-1419).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

DECISION: Hearing Decisions 17-UI-97391 and 17-UI-97414 are affirmed.
