## EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-1422

Affirmed
Late Requests for Hearing Dismissed
Overpayment Assessed

**PROCEDURAL HISTORY:** On April 13, 2017, the Oregon Employment Department (the Department) served notice of two administrative decisions concluding that claimant was not available for work from January 8 through April 8, 2017 (decision # 81757) and from February 26 through April 8, 2017 (decision # 85010). On May 3, 2017, decisions # 81757 and # 85010 became final without claimant having filed a request for hearing. On August 10, 2017, the Department served notice of an administrative decision, based on decisions # 81757 and # 85010, concluding that claimant was overpaid \$3575 in benefits (decision # 132449). On August 29, 2017, claimant filed late requests for hearing on decisions # 81757 and # 85010, and a timely request for hearing on decision # 132449. On November 16, 2017, ALJ Frank conducted hearings, and on November 22, 2017 issued Hearing Decisions 17-UI-97492 and 17-UI-97493 dismissing claimant's late requests for hearing on decisions # 81757 and # 85010, and Hearing Decision 17-UI-97495, affirming decision # 132449. On December 11, 2017, claimant filed applications for review of Hearing Decisions 17-UI-97492, 17-UI-97493 and 17-UI-97495 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-97492, 17-UI-97493 and 17-UI-97495. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2017-EAB-1421, 2017-EAB-1422 and 2017-EAB-1420).

EAB reviewed all three hearing records and claimant's written argument. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-97492, 17-UI-97493 and 17-UI-97495 are affirmed.
