EMPLOYMENT APPEALS BOARD DECISION 2017-EAB-1441

No Disqualification

PROCEDURAL HISTORY: On November 8, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 134835). Claimant filed a timely request for hearing. On December 6, 2017, ALJ Murdock conducted a hearing at which the employer failed to appear, and on December 11, 2017 issued Hearing Decision 17-UI-98741, concluding claimant left work with good cause. On December 15, 2017, the employer filed an application for review with the Employment Appeals Board (EAB).

With its application for review the employer asked for a new hearing on the grounds that he was unable to appear and present evidence on December 6th. The employer's request for relief is construed as a request to have EAB consider new information under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider information not presented at the hearing if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing. In support of his request, the employer asserted that he was prevented from attending the hearing because he was on hold with the union and "didn't notice the time till it was already over." The employer did not assert or show what, if any, attempt he made to keep track of the time and participate in the hearing despite his other call, or have someone else either call into the hearing or wait on hold for him; in the absence of such evidence, the employer has failed to show that being on hold with the union was a circumstance beyond his reasonable control. The employer's request to have EAB consider new information is, therefore, denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Hearing Decision 17-UI-98741 is affirmed.
