**EMPLOYMENT APPEALS BOARD DECISION**  
**2017-EAB-1462**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment*

**PROCEDURAL HISTORY:** On August 31, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from August 6 through 19, 2017 (decision # 150644). On September 20, 2017 decision # 150644 became final without claimant having filed a late request for hearing. On October 10, 2017, the Department served notice of an administrative decision, based on decision # 150644, concluding that claimant was overpaid \$460 in benefits that he must repay the Department (decision # 131244). On October 24, 2017, claimant filed a late request for hearing on decision # 150644 and a timely request for hearing on decision # 131244. On December 7, 2017, ALJ Janzen conducted hearings, and on December 8, 2017 issued Hearing Decision 17-UI-98566 dismissing claimant's late request for hearing on decision # 150644 as untimely without good cause, and Hearing Decision # 17-UI-98604 affirming decision # 131244. On December 21, 2017, claimant filed applications for review of Hearing Decisions 17-UI-98566 and 17-UI-98604 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-98566 and 17-UI-98604. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2017-EAB-1461 and 2017-EAB-1462).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-98566 and 17-UI-98604 are affirmed.
