## EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0020

Affirmed Disqualifications Ineligible for Regular Benefits October 1 through December 9, 2017 Ineligible for TUI Benefits

**PROCEDURAL HISTORY:** On November 3, 2017, the Oregon Employment Department (the Department) served notice of three administrative decisions concluding that claimant quit working for Ellwood Staffing Services without good cause on September 30, 2017 (decision # 111430), that claimant quit working for Game Time Sports Bar and Grill Inc. without good cause (decision # 100743), and that claimant was not available for work from October 1 through 28, 2017 (decision # 95114). On November 6, 2017, the Department served notice of an administrative decision concluding that claimant is not eligible for Training Unemployment Insurance (TUI) benefits (decision # 72706). Claimant filed timely requests for hearing on all four decisions. On December 15, 2017, ALJ Wyatt conducted hearings, and on December 22, 2017 issued Hearing Decision 17-UI-99633 concluding that claimant quit working for Ellwood Staffing Services without good cause on October 4, 2017, Hearing Decision 17-UI-99641 affirming decision # 100743, Hearing Decision 17-UI-99646 concluding that claimant was not available for work from October 1 through December 9, 2017, and Hearing Decision 17-UI-99656 affirming decision # 72706. On January 4, 2018, claimant filed applications for review of Hearing Decisions 17-UI-99633, 17-UI-99641, 17-UI-99646 and 17-UI-99656 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 17-UI-99633, 17-UI-99641, 17-UI-99646 and 17-UI-99656. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2018-EAB-0020, 2018-EAB-0021, 2018-EAB-0022 and 2018-EAB-0023).

EAB reviewed all four hearing records. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 17-UI-99633, 17-UI-99641, 17-UI-99646 and 17-UI-99656 are affirmed.
