## EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0082

Affirmed
Late Requests for Hearing Dismissed

**PROCEDURAL HISTORY:** On March 24, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 114001). On March 27, 2017, the Department served notice of another administrative decision, based in part upon decision # 114001, concluding that claimant was overpaid \$14,742.00 that he was required to repay, and assessing a \$2,211.30 monetary penalty and 52 penalty weeks (decision # 193943). On April 13, 2017, decision # 114001 became final without claimant having filed a timely request for hearing. On April 17, 2017, decision # 193943 became final without claimant having filed a timely request for hearing. On November 9, 2017, claimant filed late requests for hearing on both decisions. On November 15, 2017, ALJ Kangas reviewed claimant's requests and issued Hearing Decision 17-UI-96874, dismissing claimant's late request for hearing on decision # 114001, and Hearing Decision 17-UI-96873, dismissing claimant's late request for hearing on decision # 193943, both decisions subject to his right to renew the requests by responding to an appellant questionnaire by November 29, 2017. On November 27, 2017, the Office of Administrative Hearings (OAH) received claimant's response. On November 29, 2017, OAH mailed letters to claimant stating that Hearing Decisions 17-UI-96874 and 17-UI-96873 were canceled. On December 20, 2017, ALJ R. Frank conducted a consolidated hearing, and on January 5, 2018 issued Hearing Decision 18-UI-100337, re-dismissing claimant's late request for hearing on decision # 193943, and Hearing Decision 18-UI-100338, re-dismissing claimant's late request for hearing on decision # 114001. On January 22, 2018, claimant filed applications for review of both decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Hearing Decisions 18-UI-100337 and 18-UI-100338. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-0081 and 2018-EAB-0082).

EAB reviewed the hearing records in their entirety, as well as claimant's written argument to the extent it was relevant and based upon the hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 18-UI-100337 and 18-UI-100338 are affirmed.
