## EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0221

## Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On September 13, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for an act that disqualified him from receiving benefits (decision # 111530). Claimant filed a timely request for hearing. On September 27, 2017, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 11, 2017. On October 11, 2017, claimant failed to appear at the hearing, and ALJ M. Davis issued Hearing Decision 17-UI-94307, dismissing claimant's request for hearing due to his failure to appear. On October 31, 2017, Hearing Decision 17-UI-94307 became final without claimant having filed a request to reopen the hearing, or an application for review with the Employment Appeals Board (EAB). On November 3, 2017, claimant filed a late request to reopen the hearing claimant's request to reopen the hearing becision 17-UI-96349, dismissing claimant's request to reopen the hearing as untimely without a showing of good cause. On November 27, 2017, Hearing Decision 17-UI-96349 became final without claimant having filed an application for review with EAB. On March 1, 2018, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Hearing Decision 17-UI-96349 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. OAR 471-041-0070(1) (March 20, 2014). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing OAR 471-040-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0050(2)(b).

Here, OAH mailed Hearing Decision 17-UI-96349 to claimant on November 7, 2017. Claimant did not file his application for review of that decision until March 1, 2018, over three months after the November 27, 2017 filing deadline. In his application for review, claimant indicated that he was incarcerated from November 6, 2017 through January 8, 2018 and in "Rehab" from January 8 through

February 5, 2018, which we construe as an assertion that he therefore was prevented from tiling a timely application for review. However, claimant failed to explain why he did not file his application for review until March 1, 2018, twenty-four days after he apparently was released from rehab. Absent such an explanation, claimant failed to show that he filed his application within the required "reasonable time," seven days after the circumstances that allegedly prevented a timely filing ceased to exist. Claimant's late application for review of Hearing Decision 17-UI-96349 therefore is dismissed.

**DECISION:** The application for review filed March 1, 2018 is dismissed. Hearing Decision 17-UI-96349 remains undisturbed.
