## EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0252

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

**PROCEDURAL HISTORY:** On October 16, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 150443). On November 6, 2017, decision # 150443 became final without claimant having filed a request for hearing. On November 20, 2017, the Department served notice of an administrative decision, based on decision # 150443, concluding that claimant was overpaid \$552 in benefits that he must repay the Department (decision # 131059). On November 29, 2017, claimant filed a late request for hearing on decision # 150443 and a timely request for hearing on decision # 131059. On February 22, 2018, ALJ Frank conducted hearings, and on February 23, 2018 issued Hearing Decision 18-UI-103842 dismissing claimant's late request for hearing on decision # 150443, and Hearing Decision 18-UI-103881 affirming decision # 131059. On March 7, 2018, claimant filed timely applications for review of Hearing Decisions 18-UI-103842 and 18-UI-103881 with the Employment Appeals Board (EAB).

EAB considered both hearing records and claimant's written argument to the extent it was based on the hearing records and relevant to the only issues before EAB, whether claimant's late request for hearing on decision # 150443 is subject to dismissal, and whether claimant therefore must repay the \$552 in benefits he was paid by the Department.

On *de novo* review and pursuant to ORS 657.275(2), the hearing decisions under review are **adopted**.

**DECISION:** Hearing Decisions 18-UI-103842 and 18-UI-103881 are affirmed.
