**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-0388**

*Affirmed*  
*Late Requests for Hearing Dismissed*  
*Decisions # 95648 and 194047 Remain Undisturbed*

**PROCEDURAL HISTORY:** On October 31, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 95648). On November 15, 2017, the Department served notice of an administrative decision assessing a \$2,379 overpayment, \$475.80 monetary penalty and 21 penalty weeks (decision # 194047). On November 20, 2017, decision # 95648 became final without claimant having filed a timely request for hearing. On December 5, 2017, decision # 194047 became final without claimant having filed a timely request for hearing. On January 12, 2018, claimant filed late requests for hearing on decisions # 95648 and 194047. On January 22, 2018, ALJ Kangas issued Order No. 18-UI-101394, dismissing claimant's late request for hearing on decision # 95648, and Order No. 18-UI-101395, dismissing claimant's late request for hearing on decision # 194047, both subject to claimant's right to renew his requests by responding to an appellant questionnaire by February 5, 2018. On February 2, 2018, claimant responded to the appellant questionnaire. On March 7, 2018, the Office of Administrative Hearings (OAH) mailed letters notifying claimant that Order Nos. 18-UI-101394 and 18-UI-101395 were canceled. On March 8, 2018, OAH mailed notice of two hearings scheduled for March 23, 2018. On March 23, 2018, ALJ Amesbury conducted the hearings. On March 29, 2018, ALJ Amesbury issued Order No. 18-UI-106241, re-dismissing claimant's late request for hearing on decision # 95648, and 18-UI-106264, re-dismissing claimant's late request for hearing on decision # 194047. On April 17, 2018, claimant filed applications for review of both decisions with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 18-UI-106241 and 18-UI-106264. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-0388 and 2018-EAB-0389).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order Nos. 18-UI-106241 and 18-UI-106264 are affirmed.
