EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0465

Affirmed Disqualification

PROCEDURAL HISTORY: On January 9, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 81129). Claimant filed a timely request for hearing. On February 13, 2018, ALJ Murdock conducted a hearing, and on February 14, 2018 issued Order No. 18-UI-103292, affirming the Department's decision. On February 20, 2018, claimant filed an application for review with the Employment Appeals Board (EAB). On March 19, 2018, EAB issued Appeals Board Decision 2018-EAB-0193, reversing and remanding the case to the Office of Administrative Hearings. On April 16, 2018, ALJ Murdock conducted a hearing, and on April 18, 2018 issued Order No. 18-UI-107615, reaffirming decision # 81129. On April 30, 2018, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant failed to certify that he provided a copy of his argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision. Even if we had, the outcome of this decision would remain the same. Having reviewed the entire hearing record, it appears on review that claimant had a full and fair opportunity to provide evidence about the reason he voluntarily left work, and we agree with the ALJ that claimant did not establish that it was more likely than not that he left work with good cause.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-107615 is affirmed.
