Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On October 26, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from January 1 through 28, 2017 (decision # 115405). On November 15, 2017, decision # 115405 became final without claimant having requested a hearing on that decision. On December 4, 2017, the Department served notice of an administrative decision, based on decision # 115405, concluding that claimant was overpaid \$2,360 in benefits (decision # 140027). On December 26, 2017, decision # 140027 became final without claimant having requested a hearing on that decision.

On March 19, 2018, claimant filed late requests for hearing on decisions # 115405 and # 140027. On March 22, 2018, ALJ Kangas issued Order Nos. 18-UI-105771 and 18-UI-105773, dismissing claimant's requests for hearing as untimely without a showing of good cause, subject to his right to renew his requests by responding to an appellant questionnaire by April 5, 2018. On April 2, 2018, claimant filed a timely response to the appellant questionnaire. The Office of Administrative Hearings (OAH) considered claimant's response, and on April 4, 2018 cancelled and vacated Order Nos. 18-UI-105771 and 18-UI-105773, and scheduled hearings on claimant's late requests for hearing and, if appropriate, the merits of decisions # 115405 and # 140027.

On May 8, 2018, ALJ Frank conducted a consolidated hearing, and on May 16, 2018 issued Order Nos. 18-UI-109477 and 18-UI-109479, dismissing claimant's late requests for hearing on decisions # 115405 and # 140027. On June 2, 2018, claimant filed timely applications for review of Order Nos. 18-UI-109477 and 18-UI-109479 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 18-UI-109477 and 18-UI-109479. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-0563 and 2018-EAB-0564).

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 18-UI-109477 and 18-UI-109479 are affirmed.
