EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0836

Affirmed Eligible

PROCEDURAL HISTORY: On July 12, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was available for work during the week of June 17 through June 23, 2018 (decision # 65323). The employer filed a timely request for hearing. On July 31, 2018, ALJ S. Lee conducted a hearing, and on August 8, 2018 issued Order No. 18-UI-114608, affirming the Department's decision. On August 27, 2018, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer submitted a written argument in which, among other things, it requested that the employer's unemployment insurance tax account not be charged as a result of claimant's claim because the employer did not change claimant's work hours during the weeks at issue and gave claimant as many hours of work as it could. However, the issue before the ALJ and before EAB on review was solely whether claimant was available for work under the standards set forth in OAR 471-030-0036(3) (April 1, 2018). Those standards generally involve a claimant's willingness to accept and perform the type of work that he or she is seeking during the weeks at issue, and do not involve consideration of the hours of work that a particular employer was able to offer claimant during those same weeks. In addition, the issue of charging an employer's account as a result of a claimant's unemployment insurance claim is not a relevant consideration in determining whether claimant was available and eligible to receive benefits under OAR 471-030-0036(3). For these reasons, the employer's position as stated in its written argument is not relevant to whether claimant was available for benefits during the weeks at issue and eligible for benefits based on his availability.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-114608 is affirmed.
