## EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-0942

Affirmed – Confirmada Disqualified - Descalificado Request to Reopen Denied – Petición para Reabrir es Negada

PROCEDURAL HISTORY: On July 26, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause (decision # 133406) and an administrative decision concluding that claimant was not available for work from July 1, 2018 through July 22, 2018 (decision # 130233). Claimant filed timely requests for hearing on both decisions. On August 2, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for August 16, 2018 at 10:45 a.m. on decision # 133406, and notice of a hearing scheduled for August 16, 2018 at 9:30 a.m. on decision # 130233. On August 16, 2018, claimant failed to appear at both hearings, and ALJ Janzen issued Order No. 18-UI-115090 and Order No. 18-UI-115079, dismissing claimant's requests for hearings due to her failure to appear. Claimant filed timely requests to reopen both hearings. On September 13, 2018, ALJ Janzen conducted hearings, and on September 14, 2018 issued Order No. 18-UI-116659 granting claimant's request to reopen the hearing on decision # 133406 and affirming that decision, and Order No. 18-UI-116610 denying claimant's request to reopen the hearing on decision # 130233. On September 26, 2018, claimant filed applications for review of Order No. 18-UI-116659 and Order No. 18-UI-116610 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order No. 18-UI-116659 and Order No. 18-UI-116610. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-0942 and 2018-EAB-0943).

On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Orders No. 18-UI-116659 and No. 18-UI-116610 are affirmed. Las Ordenes de la Audiencia No. 18-UI-116659 y No. 18-UI-116610 son confirmadas.
