

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-0964-R

Late Request for Reconsideration Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 10, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not eligible to receive benefits during the period between two academic years, which were weeks 24-18 through 34-18 (decision #63518). Claimant filed a timely request for hearing. On August 6, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for August 20, 2018, at which claimant failed to appear. On August 21, 2018, ALJ Murdock issued Order No. 18-UI-115280, dismissing claimant's request for hearing for failure to appear. On August 27, 2018, claimant filed a request to reopen the August 20, 2018 hearing. On September 4, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for September 17, 2018. On September 17, 2017, ALJ S. Lee conducted a hearing, and on September 25, 2018 issued Order No. 18-UI-117148, granting claimant's request to reopen the hearing and affirming decision #63518. On October 4, 2018, claimant filed an application for review with the Employment Appeals Board (EAB). On November 9, 2018, EAB issued EAB Decision 2018-EAB-0964, concluding that claimant was not eligible to receive benefits for weeks 25-18 through 34-18. On November 29, 2018, EAB Decision 2018-EAB-0964 became final without claimant having filed a request for reconsideration with EAB. On December 10, 2018, claimant filed a late request for reconsideration with EAB.

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration of EAB Decision 2018-EAB-0964 is dismissed.

On December 10, 2018, the Employment Appeals Board received a letter in which the appellant asked for review of EAB Decision 2018-EAB-0964. A party may request reconsideration of an EAB decision to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rules, positions or practices. ORS 657.290(3); OAR 471-041-0145(1). A reconsideration request is subject to dismissal if filed more than 20 days from the date on which the EAB decision was mailed. The EAB decision at issue was mailed on November 9, 2018. The appellant's request for reconsideration was filed on December 10, 2018, which is more than 20 days after the date the EAB decision at issue was mailed. The reconsideration request is, therefore, dismissed as untimely.

DECISION: The request for reconsideration filed December 10, 2018 is dismissed. EAB Decision 2018-EAB-0964 remains undisturbed.
