EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-0988

Affirmed
Request to Reopen Allowed
Disqualification

PROCEDURAL HISTORY: On June 7, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 82619). On June 12, 2018, claimant filed a request for hearing. On June 20, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 3, 2018, at which the employer failed to appear. On July 3, 2018, ALJ Scott conducted a hearing, and on July 9, 2018 issued Order No. 18-UI-112723, concluding that claimant voluntarily left work with good cause. On July 30, 2018, the employer filed a timely request to reopen the July 3, 2018 hearing. On August 8, 2018, OAH mailed notice of a hearing scheduled for August 21, 2018. On August 21, 2018, ALJ Shoemake conducted a hearing, ruled on the record that the employer's request to reopen was allowed, and continued the hearing to a later date. On August 22, 2018, OAH mailed notice of the continued hearing scheduled for September 18, 2018. On September 18, 2018, ALJ Shoemake conduct a hearing, and on September 24, 2018 issued Order No. 18-UI-117063, stating that the employer's request to reopen the hearing was allowed and concluding that claimant voluntarily left work without good cause. On October 9, 2018, claimant filed a timely application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 18-UI-117063 is affirmed.
