

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-0998-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On August 17, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause (decision # 95433). Claimant filed a timely request for hearing. On September 18, 2018, ALJ Shoemake conducted a hearing, and on September 24, 2018 issued Order 18-UI-117096, concluding that the employer discharged claimant, not for misconduct. On October 15, 2018, the employer filed an application for review with the Employment Appeals Board (EAB). On November 19, 2018, EAB issued EAB Decision 2018-EAB-0998, concluding that claimant quit working for the employer without good cause. On November 26, 2018, claimant filed a request for reconsideration of EAB Decision 2018-EAB-0998.

CONCLUSIONS AND REASONS: Claimant's request for reconsideration of EAB Decision 2018-EAB-0998 is dismissed.

ORS 657.290(3) provides that EAB, upon application of any party in interest, may reconsider any previous decision of the EAB. A party may request reconsideration to correct an error of material fact or law, or explain any unexplained inconsistency with Department rule, officially stated Department position or prior Department practice. OAR 471-041-0145(1) (October 29, 2006). However, the request is subject to dismissal unless it includes a statement that a copy has been provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered is mailed. OAR 471-041-0145(2). Here, claimant's request for reconsideration of EAB Decision 2018-EAB-0998 did not include a statement that a copy had been provided to the employer, as required. Claimant's request for reconsideration therefore is subject to dismissal.

Claimant's request for reconsideration of EAB Decision 2018-EAB-0998 therefore is dismissed.

DECISION: The request for reconsideration filed November 26, 2018 is dismissed. EAB Decision 2018-EAB-0998 remains undisturbed.
