**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1054**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment*

**PROCEDURAL HISTORY:** On August 23, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able, available, or actively seeking work from July 22, 2018 to July 28, 2018 (decision # 94722). On September 12, 2018, decision # 94722 became final without claimant having filed a timely request for hearing. On September 26, 2018, the Department served notice of another administrative decision, based on decision # 94722, assessing a \$624 overpayment that claimant was liable to repay (decision # 80203). On October 2, 2018, claimant filed a late request for hearing on decision # 94722, and a timely request on decision # 80203. On October 24, 2018, ALJ Snyder conducted two hearings. On October 31, 2018, the ALJ issued Order No. 18-UI-119029, dismissing claimant's late request for hearing on decision # 94722. On November 1, 2018, the ALJ issued Order No. 18-UI-119049, affirming decision # 80203. On November 6, 2018, claimant filed timely applications for review of both Orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 18-UI-119029 and 18-UI-119049. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-1054 and 2018-EAB-1055).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order Nos. 18-UI-119029 and 18-UI-119049 are affirmed.
