

**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1077**

*Reversed & Remanded*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 24, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding benefits based on educational wages in claimant's base year were not payable to her during the August 12, 2018 to September 22, 2018 recess period (decision # 113537). Claimant filed a timely request for hearing. On October 22, 2018, ALJ Murdock conducted a hearing, and on October 26, 2018 issued Order No. 18-UI-118821, affirming the Department's decision. On November 15, 2018, the Oregon Employment Department filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Order No. 18-UI-118821 is set aside as unsupported by a complete record, and this matter remanded.

ORS 657.167 provides, in pertinent part, that if certain conditions are met benefits based on service in an instructional capacity for an educational institution or institution of higher education are not payable in any week of unemployment commencing during such institutions' recess periods. The ALJ found, based upon testimony from the Department's witness, that all of claimant's base year wages in this case came from educational institutions or institutions of higher education, and, therefore, that because the conditions set forth in ORS 657.167 were met benefits were not payable to claimant during the applicable recess period. *See* Order No. 18-UI-118821 at 1, 3. According to the Department's written argument to EAB, however, the Department's witness testified in error as to the source of some of claimant's base year wages and reduced benefits should be payable to claimant because she is monetarily eligible for benefits based upon her non-educational wages during the applicable recess period. Because it appears that the evidence upon which the ALJ's decision was based is not reliable, the record does not support a determination in this case. This matter is therefore set aside, and remanded to the Office of Administrative Hearings (OAH) for another hearing and hearing decision.

**DECISION:** Order No. 18-UI-118821 is set aside, and this matter remanded for further proceedings consistent with this order.
