

EMPLOYMENT APPEALS BOARD DECISION
2018-EAB-1080

Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On October 3, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant but not for misconduct (decision # 65949). The employer filed a timely request for hearing. On November 6, 2018, ALJ R. Frank conducted a hearing, at which claimant failed to appear, and on November 14, 2018 issued Order No. 18-UI-119698, concluding the employer discharged claimant but not for misconduct. On November 16, 2018, the employer filed an application for review with the Employment Appeals Board (EAB). On December 7, 2018, claimant filed a late request to reopen the November 6th hearing with the Office of Administrative Hearings (OAH).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

ORS 657.275 provides that EAB shall review the record of the case promptly and affirm, modify, or set aside the decision of the ALJ if the Director of the Department or any interested party files a timely application for review. EAB commenced review of this matter based upon the employer's timely and valid application for review. However, it appears that claimant subsequently initiated further proceedings at the Office of Administrative Hearings (OAH) by requesting to reopen the November 6th hearing, and this matter therefore is not yet ripe for review at EAB. We therefore dismiss the employer's application for review without prejudice to allow the proceedings at OAH to be completed.

If OAH does not issue a new order, the employer has the right to request that EAB review this matter based upon its November 16, 2018 application for review. If OAH issues a new order, both parties will have the right to appeal the new order to the Employment Appeals Board by filing a new application for review.

DECISION: The application for review filed November 16, 2018 is dismissed without prejudice. Order No. 18-UI-119698 remains undisturbed
