**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1085**

---

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 19, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 100219). Claimant filed a timely request for hearing. On October 16, 2018 and October 31, 2018, ALJ S. Lee conducted a hearing, and on November 5, 2018 issued Order No. 18-UI-119222, concluding the employer discharged claimant but not for misconduct. On November 16, 2018, claimant filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On November 19, 2018, the Employment Appeals Board (EAB) received from the appellant what appears to be an application for review of an order that allowed the appellant benefits. After reviewing Order No. 18-UI-119222 and the application for review, EAB has concluded that the appellant's application for review must be dismissed.

In the application for review, the appellant did not assign error to any portion of the decision and did not request reversal of any portion of the decision. In consideration of our obligation to issue decisions that are consistent with sound principles governing judicial review and address only existing controversies between parties, we decline to address matters that will have no practical effect on the rights of the parties to the controversy. See *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995); *Brumnett v. PSRB*, 315 Or 402, 848 P2d 1194 (1992).

Because the case before us presents no justiciable controversy, the application for review of Order No. 18-UI-119222 is dismissed. Order No. 18-UI-119222 remains undisturbed.

**DECISION:** The application for review filed November 16, 2018 is dismissed. Order No. 18-UI-119222 remains undisturbed.
