EMPLOYMENT APPEALS BOARD DECISION 2018-EAB-1089

Reversed & Remanded

PROCEDURAL HISTORY: On September 5, 2018, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding that claimant was willfully failed to report earnings and therefore was overpaid \$4,832 in benefits, and is disqualified from 32 weeks of future benefits and assessed a \$1,449.60 monetary penalty (decision # 200323). On September 25, 2018, decision # 200323 became final without claimant having filed a request for hearing. On October 21, 2018, claimant filed a late request for hearing. On October 29, 2018, ALJ Kangas issued Order No. 18-UI-118892 dismissing claimant's request for hearing as untimely without a showing of good cause to extend the filing deadline to October 21, 2018, subject to claimant's right to renew his request by filing a response to an appellant questionnaire by November 12, 2018. On November 14, 2018, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 18-UI-118892 with the Employment Appeals Board (EAB). On November 20, 2018, ALJ Kangas notified claimant that because his response to the appellant questionnaire was not filed within the designated time period, it would not be considered, OAH would not issue another order regarding claimant's late request for hearing, and Order No. 18-UI-118892 remained in effect.

Claimant included his response to the appellant questionnaire with his timely application for review of Order No. 18-UI-118892 with EAB. Claimant's response to the appellant questionnaire is marked and received into evidence as EAB Exhibit 1 under OAR 471-041-0090(1) (October 29, 2006), which allows EAB to receive into evidence exhibits offered, but not received, into the hearing record, as necessary to complete the record. Any party that objects to the admission of EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(3) (October 29, 2006). Unless such objection is received and sustained, EAB Exhibit 1 will remain in the record.

CONCLUSIONS AND REASONS: Order No. 18-UI-118892 is reversed and this matter remanded for a hearing on whether to allow claimant's late request for hearing and, if so, the merits of decision # 200323.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date is it mailed. ORS 657.875 provides that the 20-day deadline may be

extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The Department mailed decision # 200323 to claimant on September 5, 2018. In his response to the appellant questionnaire, claimant asserted that he did not file a request for hearing on decision # 200323 until October 21, 2018 because he was away from his residence for several weeks and did not check his mail until after he returned, and therefore did not personally receive decision # 200323 until October 21st. Department records show that claimant stopped claiming benefits after August 13, 2018, ¹ meaning that claimant had no apparent reason to expect mail from the Department in September 2018. Claimant therefore may have had good cause to extend the deadline for filing a request for hearing on decision # 200323 to October 21, 2018. However, more information is needed to make that determination, including the date claimant left his residence, whether he had any reason to expect mail from the department while he was away, the date he returned to his residence, and the date he checked his mail and became aware of decision # 200323. Order No. 18-UI-118892 therefore is reversed and this matter remanded for a hearing on whether to allow claimant's late request for hearing and, if so, the merits of decision # 200323.

DECISION: Order No. 18-UI-118892 is set aside, and this matter remanded for further proceedings consistent with this order.
