**EMPLOYMENT APPEALS BOARD DECISION**  
**2018-EAB-1102**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On August 20, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 84211). On September 10, 2018, decision # 84211 became final without claimant having filed a timely request for hearing. On September 20, 2018, the Department served notice of another administrative decision assessing a \$5,193 overpayment claimant was required to repay (decision # 111736). On October 5, 2018, claimant filed a late request for hearing on decision # 84211 and a timely request for hearing on decision # 111736. On October 23, 2018, the Office of Administrative Hearings (OAH) mailed notice of two hearings scheduled for November 6, 2018. On November 6, 2018, ALJ Murdock conducted both hearings. On November 8, 2018, the ALJ issued Order No. 18-UI-119425, dismissing claimant's late request for hearing on decision # 84211, and Order No. 18-UI-119424, affirming decision # 111736. On November 21, 2018, claimant filed applications for review of both Orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 18-UI-119425 and 18-UI-119424. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2018-EAB-1101 and 2018-EAB-1102).

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order Nos. 18-UI-119424 and 18-UI-119425 are affirmed.
